7. How did you help your "dead" father get un-stuck on the other side? (**2 minutes**)
8. How can our listeners help their deceased loved ones on the other side? (**1 minute**)
9. You say in your book that spirits love to talk with us through magic numbers and letters. How? (**2 minutes**)
10. You write in your book that you once perceived a "fear spirit" leaving your body. Tell us, how does it feel to go thru a spontaneous exorcism? (**1 minute, 30 seconds**)

17. Can you give us an example of your having a mystical experience as a child? (**45 seconds**)
18. What is shamanism? (**1 minute, 20 seconds**)
19. Has shamanism helped you with health or personal matters? (**30 seconds**)
20. What would be your bottom line message to people who might be interested in embarking on a journey into the mystic and following a spiritual path, and why? (**1 minute**)
