**Proving whether or not your mystical experience was real.** Selecting the proper judge and jury is the key. What questions to ask. Whose advice to seek, and whose to take. The value of an expert opinion. How to evaluate the evidence and come to a final determination.

**Ancient knowledge about the Mystic is reemerging thru shamanism,** the spiritual practice that predates organized religions by thousands of years. Shamanism involves journeying into the Spirit World to access information, solve problems, and encounter healing.
